 - c. You have a business phone number that is listed with directory assistance as a retail business.
3. **Verification** – Please attach all the following to your application:
 - a. One picture of your storefront or printout of your online store's front page.
 - b. A copy of your state business license
 - c. CA Resellers permit (CA resellers only)

Your application will be reviewed by our staff and you will be notified about acceptance as quickly as possible. If you would like to place an order at the time you apply, please enclose it with your application. Once requirements have been satisfactorily met, your orders will be sent out on a prepayment basis (company check, COD, credit card, Paypal, Wire TT).

To qualify for Dealership status, your initial purchase must exceed \$1500. To qualify for Distributorship status, your initial purchase must exceed \$10,000.
